



**Amendment of Independent Living COVID -19 Protocols**  
**Effective Date March 8, 2021**

**Visitation**

Monday – Friday, testing times will be every 30 minutes beginning 9:00 am until 11:00 am and from 12:30 pm until 3:00 pm.

- If resident or essential caregiver visitor is unvaccinated, still limited to 1 visit per essential caregiver, per week. Visitors and resident will still be required to wear a KN95 mask and shield during visit. Visitor will still be tested at each visit at their expense.
- If both visitor and resident are vaccinated, shields are not required, but must stay masked with either a surgical or KN95 mask during visit.
- Visitors and residents who are both vaccinated can have unlimited weekday visitations (with proof of vaccination of visitor). Visitor will still be tested at each visit at their expense.
- There will be no time duration restriction on visitation, but visitors must exit by 5:00 pm.
- Visitors will no longer need to check in or out of buildings.
- Visitor must stay in resident's unit; no common area visitations are allowed.

**Inter-building visitation**

- Independent Living residents wishing to visit residents in other Independent Living buildings may do so while remembering to practice social distancing and wearing the appropriate mask.
- If a resident is on "10 day watch", resident must still sign up through Sign Up Genius and go through the screening and testing protocols to visit residents on health center/assisted living floors.
- If residents have not left campus, resident visiting a health center or assisted living floor will still need to sign up on Sign Up Genius and proceed to Vista garage for check in prior to the scheduled visit, but will not be tested.



## Watch Status

For vaccinated residents who use their own transportation as well as those who use CC Young transportation to leave campus.

- Placed on “10 day watch” status when you return.
- Required to wear KN95 mask while on watch in common areas.
- Residents will be allowed to eat in open dining. CC Young will no longer have restricted areas in the dining rooms. **Residents can ask not to be seated with someone who is on “watch” status.** Staff will have a list of residents on watch and can guide them to another table if they do not have unmasked contact while eating with someone who is on watch status. Staggered dining will remain to help with social distancing.
- ER and hospital stays/visits – placed on same “10 day watch” status.

For unvaccinated residents who use CCY transportation to doctor appointments **ONLY**

- Placed on “10 day watch” status when you return.
- Required to wear KN95 mask while on watch in common areas.
- Residents will be allowed to eat in open dining. CC Young will no longer have restricted areas in the dining rooms. **Residents can ask not to be seated with someone who is on “watch” status.** Staff will have a list of residents on watch and can guide them to another table if they do not have unmasked contact while eating with someone who is on watch status. Staggered dining will remain to help with social distancing.

## Quarantine

For unvaccinated residents who use their own transportation to leave campus or use CC Young transportation to stores.

- Resident will quarantine for 10 days.
- At the end of the 10 day watch period, resident will be COVID tested.



- **Temperature Checks** – Temperature checks will only be performed on residents Monday – Friday on residents who are on “watch” status.
- **Bus trips** – Hillside transportation to Tom Thumb and bank only Wednesday and Friday as well as Kroger run will resume as scheduled. Residents may not visit any other places other than those mentioned on these trips.
- **Masking** – May wear surgical masks when in common areas unless on “watch” status.
- **Resident Lead Bible Study** is permissible provided everyone is masked.
- **Resident Lounge/Mockingbird Point** - Activities (coffee, cards, dominoes, happy hour) are permissible with everyone masked while at tables during activity. You cannot participate if on “watch” status, this is due to the inability to social distance and being unmasked while eating or drinking.
- **Deliveries** - Amazon, UPS, FedEx, pharmacy and similar services (prepared food deliveries, Pizza, Door Dash) will make deliveries directly to the resident apartments. If a family member wants to drop off items for a resident, they will need to use Sign Up Genius and it will be treated as a visitation. CC Young will not be accepting packages at the gate.
- **Business Office in the Hillside** – Will reopen to residents.

**Amendment to the Point COVID-19 Protocols  
Effective Date March 8, 2021**

- **NEW** - Surgical Masks required at Point unless on watch which requires a KN95 mask.
- Continue with good handwashing practices and frequent use of hand sanitizer stations located throughout building.
- Residents are asked to sign in to register their attendance and participation in a fitness class, workout in the gym, attend a small group meeting (e.g. happy hookers, bible study, senior scribblers, knotty knitters, etc.), attend a movie or visit the library. This will assist our team with contact tracing information and assist us with key performance indicators.



- **NEW** - CCY Residents will be responsible for sanitizing equipment in the Fitness Center and Fitness Center Classroom before and after use and/or class.
- **NEW** - CCY Fitness center surgical masks unless on watch which requires a KN95 mask, cleaning supplies and reminder signage placement will be made highly visible.
- **NEW** - Expand The Point hours of operation 7:00 am – 8:00 pm daily. This would give CCY Residents access to the building, point café, ping pong, library and Dakim equipment 7 days a week.
- **NEW** - Expand Point Café hours to 7:00am – 3:00 pm daily.
- **NEW** – Point room capacity to be posted in each space; included with sign-in sheet information and reviewed with each instructor or meeting organizer. Only seating for maximum capacity will be provided in each space. Any exception to these attendance numbers must be approved in advance in writing by the CC Young President.
